

The Jump Yard Waiver and Release of Liability Assumption of Risk and Indemnification Agreement

In Consideration of being allowed to enter the play areas and/or participate in any public play/open bounce, parties, activities, and/or programs at The Jump Yard in North Royalton, Ohio, the undersigned, on his or her behalf, and on the behalf of the participant(s) identified below, acknowledges, understands and agrees to the following conditions:

I represent that I am the parent or legal guardian of the participant(s) named below, or I have obtained permission from the parent/legal guardian of the participant(s) named below to execute this agreement on their behalf. I agree that the participant(s) named below and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions for participation in any public play/open bounce, party, activity, and/or program at The Jump Yard and further acknowledge that failure to do so may result in expulsion from The Jump Yard. In addition, myself and the participant(s) named below will immediately inspect any area upon entering it and warrant that our entry therein and/or the participant(s)' participation constitutes an acknowledgement that we have inspected the area and find it safe and reasonably suited for the purpose of its use. If I or the participant(s) listed below observe any hazard during our participation, we will bring it to the attention of the nearest Jump Yard employee or official immediately and I will remove myself and the participant(s) from the area and preclude the participant(s) from further participation in the activity;

I understand that use of the play areas and inflatable equipment, and/or participation in The Jump Yard public play/open bounce, parties, activities, and/or programs, inherently creates risk of injury or death, and I, on behalf of myself and the participant(s) named below, knowingly and freely assume all such risks, both known and unknown, including those that may arise out of the negligence of other participants, The Jump Yard and/or its employees.

I, for myself and the participant(s) named below and our respective heirs, assigns, administrators, personal representatives, and next of kin, hereby release, indemnify, and hold harmless Impact Global LLC / dba The Jump Yard, their affiliates, officers, members, agents, employees, and other participants and sponsoring agencies from and against any claims, damages, injuries and/or liabilities arising out of or related to participation in any and all Jump Yard public play/open bounce parties, activities, and/or programs, and any use of the Jump Yard play area(s), toys and inflatable equipment now or in the future.

I HAVE READ THIS WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT AND FURTHER RECOGNIZE AND AGREE THAT I AM EXECUTING IT ON BEHALF OF MYSELF AND ON BEHALF OF THE PARTICIPANT(S) NAMED BELOW AND THAT I DO SO VOLUNTARILY WITH THE UNDERSTANDING THAT IT MAY AFFECT MY OR THE PARTICIPANT(S)' LEGAL CLAIMS FOR DAMAGES IN THE EVENT OF DEATH OR INJURY TO ME OR THE PARTICIPANT(S).
